1. THE NAME OF THE SOCIETY.

The name of the society shall be the Ram Narayan Education Society, Founded

2. ADDRESS OF THE REGD. OFFICE

The Registered office of the society shall be at 3-D-158, NIT, Faridabad, Haryana

3. AREA OF OPERATION

The area of operation of the society shall be whole of Haryana.

4. AIMS AND OBJECTS:

The aims and the objects of the society



i. To establish, finance, manage and run educational institutions, from the lowest level to highest level like preparatory schools, Middle Schools, Hr. Sec. Schools, Degree Colleges, College of Education, Professional Courses Institutions like Engg. Degree College, Polytechnic with different diploma courses, Medical Colleges, BDS Colleges, Physical Education Institute, De-Pharmacy Courses etc.

ii. To impart health education through Yoga from the very beginning even in preparatory schools so as to build National heritage for the welfare of the society as a whole. The society will run its educational institutions with the update infrastructures like computerization from the beginning along with environmental conditioning to match with the western standard so as to check the people, for going abroad for education. The society is planning to provide advanced information technology in its institutions so as to prove worth of Indian children.

iii. To purchase, take on lease, accepts as gift or otherwise acquire any land or building which may be necessary or convenient for the purpose of fulfillment of the aims and objects of the Society

iv. To construct or alter any building which may be necessary or convenient for the purpose of fulfillment of aims and objects of the Society.

**RULES AND REGULATIONS**  
**OF**  
**RAM NARAYAN EDUCATION SOCIETY**

**3-D-158, NIT, FARIDABAD, HARYANA.**

**Introduction**

Different eminent personalities from different fields have joined to constitute a Education Society under the name and style **Ram Narayan Educational Society, 3-D-158, NIT, Faridabad, Haryana.**

The Seven Founder member have contributed Rs.10000/- (Rupees ten thousand only) each as initial subscription and have consented to donate more funds as per their capacity for the purpose of running different professional educational institutes at Faridabad and surrounding area wherever the land will be available for the institutions. These founder / Promoter members will also be termed as life members of the Society. Besides these members, the membership will be open to all persons of above 18 years of age regardless of caste or creed, who will depose higher faith in the aims and objects of the Society. The members of the society will be categorized as under.

- I. a) **Life Members**: Besides the seven founder members as mentioned in the Memorandum of Association of the Society any citizen of India not below the age of 18 years who gives a donations amounting to Rs.50000/- (Rs. Fifty thousand only) or as determined by the society / Managing Committee from time to time may become a life member of the society with the prior approval of the Managing Committee.

If the payment by installment is desired by a new member. This should be completed within one year, but the life member shall acquire the right to membership only after full subscription has been paid.

- b) **Donor Member / Patrons**: Any citizen of India, not below the age of 18 years, who gives a donation amounting to Rs.1,00,000/- (Rs. One Lac only) will be the Donor Member / Patrons of the society and will enjoy all membership rights. Such members will not need to pay any subscription. The admission of Donor Member / Patrons is also subjects to the approval of the Managing body.

- C **General Members**: Any citizen of India, not below the age of 18 years, whosoever depose faith in the rules and regulations of the Society and want to become the member of the Society with the mere admission fee of Rs.5100.00 (Rs. Five thousand one hundred only) The General members will have to pay the subscriptions of Rs. 5100.00 (Rs. Five thousand one hundred only) annually and shall be entitled to vote at the meeting of the society only after completion of three years, and in case his subscription is not in arrears.

CORPORATE MEMBERS.

A Corporate body having the similar aims and objects and deposing the faith in the rules and regulations of the society may become the corporate members of the Society on paying the life membership fee of Rs.50,000 (Rs. Fifty Thousandonly) or as determined by the Managing Committee of the Society from time to time. Such corporate Body may nominate one of its members to act on its behalf.

3.

HONORARY MEMBERS.

Any person of eminence may be elected as Honorary Members on the recommendation of the Managing committee of the Society for such period as they may feel proper, but not exceeding one term of the Committee at a time.

The number of Honorary Members shall not exceed 1/5<sup>th</sup> of the total number of life members. The Honorary Members shall have all the right of life members.

4.

MEMBERSHIP FEE

All the Life members shall pay Rs. 100,000/- (One hundred one hundred only) per annum or as prescribed from time to time by the Society/ Managing Committee as Annual Membership Fee.

5.

NON PAYMENT OF SUBSCRIPTION

A member will cease to be a member of the society, if he does not pay due subscription for a continuous period of two years.

6.

MANAGING COMMITTEE.

All Life Members, Patrons/Donors Members, Honorary Members and Ex-Officio Members of the Society shall elect Managing committee at the General Meeting of the Society. Managing Committee will consist of minimum seven and maximum twenty one members including Founder Members, Honorary Members and Ex-Officio Members.

Patrons will be Ex-Officio Members of the Managing Committee. Members of the Vidhan Sabha and Parliament of the concerned constituency, where the institution will be existing, will be the Ex-Officio Members of the Managing Committee.

The Managing Committee shall have the following office bearers :-

- i. President
- ii. Vice President
- iii. Secretary
- iv. Joint Secretary
- v. Treasurer

- vii) To raise and borrow money or bonds, promissory notes or any other obligations on securities sounded or based upon all or any of the properties or assets of the society without any security or upon such terms and conditions as the Managing Body may think fit.
- viii) To lease or let any properties of the Society on such terms and conditions as they may think fit and proper.
- ix) To invest the funds of the Society in or upon such securities as they may deem fit from time to time.
- x) To make such grants as they think fit for the benefit of any employee or employees of the Society.
- xi) To make such rules and bylaws, they consider necessary from time to time for regulating the Management of the Institution.



# MEETING OF THE MANAGING COMMITTEE

- i) The Managing Committee shall meet at least once a year. The report, balance sheet and accounts for the previous year must be passed at one of these meetings.
- ii) All meeting shall be summoned by the Secretary, who will give seven days notice for such meetings. Meeting of the society/Managing committee may be held at Faridabad or at any other institution of the society, wherever it will be situated.
- iii) The Quorum of the General body meeting shall be constituted with the 1/3 of the total members of the Society. After the agenda has been issued for meeting, any member may sent to the Secretary his/her view in writing and all the items in the agenda and the same shall be placed before the members in the meeting.
- iv) The president shall preside over the meeting and in his absence the Vice President shall preside.
- v) The record of the meeting of the General Body and Managing Committee as well as of the Society shall be kept by the Secretary/Joint secretary and signed by the person presiding at the next meeting of the Society/Managing Committee.

12. EMERGENT MEETING.

The President or Secretary concerned shall have the power to call an emergent meeting of the general body at any time and place to decide any urgent matter which shall be stated in the agenda drawn up by the president or by the Secretary in consultation with President.

13. ACCOUNTS

The Managing Committee shall cause true accounts to kept of the Society's transaction and of all sums and moneys received and expended by them, and the matters in respect of which such receipts and expenditure take place and the credits liabilities of the Society. The Book of accounts shall be kept in the office of the Society.

14. AUDITORS.

The Managing committee shall appoint auditors for each period and on such Remuneration as they think fit.

15. GENERAL MEETING OF THE SOCIETY

- i) The General meeting of the society shall be held once in three years and 1/3 member on roll shall constitute the quorum for the meeting. If sufficient quorum is not present, the General Meeting may be adjourned to such date as the President may determine and no quorum shall be required for the adjourned meeting.
- ii) The Managing Committee may of their own motion or on the written requisition of seven members shall call on extra ordinary General Meeting of the Society. The notice of such meeting and the subject thereof shall be served to each member of the Society with notice of at least 15 days before the date fixed for the meeting.

16. POWERS AND DUTIES OF OFFICE BEARERS.

a) PRESIDENT.

- i) The President shall be the Executive head of the General Body and Managing Committee.
- ii) He shall be Ex-Office Member and Chairman of all Governing councils of all institutions run by the Society.
- iii) The President shall discharge all such functions and exercise such authority as are delegated to him by the Managing Committee.
- iv) He shall preside over the meeting of the General Body and also of Managing Committee and Governing Councils.

7. ELECTION OF THE OFFICE BEARERS.

All the office bearers shall be elected by the Managing Committee at the General Meeting of the Society to be held for this purpose and they shall hold office for a period of three years only, but will be eligible for re-election.

8. HOW MEMBERSHIP CEASES.

A person shall cease to be a member:-


- i. On death or resignation.
- ii. On being adjudged of unsound mind or insolvent by a competent court of law.
- iii. On conviction passed by an offence involving moral turpitude and on being at a meeting of the members passed by a majority of 2/3 members presents provided that such resolution form  of the agenda circulated to the members at least a week before the date of the meeting in which it is passed.

9. FILLING OF THE VACANCY

Any vacancy following in the Managing Committee before the next election shall be filled up by co-option of the Managing Committee from amongst the membership of the Society until the next election.

10. POWERS OF THE MANAGING COMMITTEE

- i) To carry on the Management of the institutions set up by the Society.
- ii) To appoint the Faculty Staff, Principal, Teachers and others employees for institutions and to approve their terms and conditions of service.
- iii) To take on lease or accept as gift or to Purchase any land for building which may be necessary or convenient for the purpose of the Society and on such terms and conditions as they may think fit and proper.
- iv) To construct any building or buildings, which may be necessary for the purpose of the Society and make any additions or alterations to any building, or buildings hold by the society.
- v) To exchange or otherwise dispose of any properties of the society, movable or immovable on such terms and conditions as they may think proper.
- vi) To enter into any arrangement with the Government or any other person or persons for receiving grants for the Institutions.
